1. Consent to Participate

I hereby give my permission for my daughter/ward, _____, age _____, to participate in the Young Women's Technology Workshop, being held on March 2, 2018, at the NetApp, Inc. Research Triangle Park. In case of an emergency and if I cannot be reached, I authorize the Workshop, NetApp personnel and medical personnel to provide medical treatment for my daughter. I understand that NetApp strongly recommends that I carry health or accident insurance for my daughter/ward. I further understand that the Workshop does not carry insurance to cover injuries or other events, nor does the Workshop accept liability for such injuries.

2. Incidental Use of Audio, Video, Photo

The Young Women's Technology Workshop may elect to record the presentations and remarks made by speakers and other activities occurring at the Workshop, and to edit and use the same, for both internal and external publically facing education purposes consistent with the overall purpose of the Workshop, including promotional activities for future Workshops. External viewing of such recordings and presentations may be available through social media sites such as YouTube. Although any such activity would be primarily directed to the recording of presentations and remarks of Workshop speakers, it is possible that such activities may include incidental recording of the image, speech or likeness of my daughter/ward, including the recording of any comments, questions or remarks made by my daughter/ward. I, my daughter/ward and our families therefore grant permission to the Workshop and its assigns to make mention of and to record audio and visual likenesses of my daughter/ward, and to edit, modify and use the resulting sounds and images in any manner consistent with the purposes articulated above and the overall purpose of the workshop. Inspection or approval of any recording or written copy or other transcription is waived. I further acknowledge that NetApp is the owner of all rights in and to the video, film or photographs of my daughter's/ward image.

3. Release and Waiver of Claims

In order for my daughter/ward to participate in the Young Women's Technology Workshop, I hereby waive and release any and all claims against the Workshop, NetApp Inc., CTO Office, volunteers and employees, for injury, accident, illness or death arising from my daughter's/ward's presence during or by reason of her participation in this Workshop. This release encompasses all claims, demands, actions, causes of actions, suits, damages, losses, costs, attorneys' fees and /or expenses, known or unknown, which I may claim to have to against the Workshop, NetApp Inc., CTO Office, volunteers and employees or arising from presence on any facility where the Workshop is conducted and I hereby promise not to assert any such claims, demands, actions or causes of actions. I expressly waive and relinquish all rights and benefits afforded by Section 1542 of the Civil Code of the State of California, or comparable applicable state statute, which states as follows:

"A general Release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the Release, which if known by him or her must have materially affected his or her settlement with the debtor."

Thus, notwithstanding Section 1542, I acknowledge that this release extends to all claims including those which I do not know at the time of execution, and that release extinguishes any and all such claims. I acknowledge that the only consideration for signing this release is the terms stated herein and the ability of my daughter/ward to attend the workshop, and that no other promise or agreement of any kind, verbal or otherwise, has been made to or with me by any person or entity whomsoever to cause me to execute this Agreement. This Parental Release shall be binding upon my relatives, personal representatives, heirs, beneficiaries, next of kin, or assign and shall inure to the benefit of NetApp and its successors and assigns.
